Subject: Preparation of State of Environment Report for Maharashtra, 2020

Respected Director/ Vice Chancellor,

The Ministry of Environment, Forest and Climate Change (MoEF&CC), GoI and the ENVIS scheme have notified all States and Union territories to prepare the State of Environment Report (SoER) (as mentioned in letter vide No. 8/5/2020-21/EI, issued by MoEF&CC dated 5.07.2021). The State of Environment Report will provide concrete guidance for environmental action planning, policy setting and resource allocation for the coming decades. It is based on sound integrated analysis of the state and trends of the environment for each sector using the internationally acknowledged DPSIR framework (Drivers-Pressures-State-Impacts-Response).

Previous SoER for Maharashtra was published in 2007 and the mandate has now been updated to ensure uniformity of the report nationally by using the DPSIR framework. The Ministry of Environment, Forest and Climate Change (GoI) has appointed 40 empanelled institutions to prepare the report.

With background to this, the Department of Environment and Climate Change (GoM) is proposing preparation of the State of Environment Report for Maharashtra (2020) and requesting the empanelled institutions (as mentioned in O.M. issued by MoEF&CC vide F.No.8/2/2014-15/EI dated 22.09.2016) to submit their proposals.

Interested agencies should submit their proposals as per the format given in the RFP. The Technical proposal and the Financial Proposal (RFP, Annexure 1) should be submitted in separate sealed envelopes marked as "TECHNICAL BID" and "FINANCIAL BID" respectively and these should be kept in an enclosed sealed envelope marked as "BIDS FOR SOER-MAHARASHTRA-2020".

Both the proposed sealed envelopes should reach the departmental office no later than 11th October, 2021 by 17:00 through post/physically. Envelopes received late due to delays in post or otherwise will not be considered. The institutions can send clarifications till 28th September, 2021 by 17:00.
